AFFECTED INVESTORS


This matter came before the Court upon Michael A. Grassmueck's (the "Receiver") Motion for Order Authorizing Notice and Filing Procedures Regarding Affected Investors (Docket No. 70) (the "Motion"). In the Motion, the Receiver sought an order authorizing him to follow certain procedures in providing notice to investors in a manner that maintains the privacy of their personal identification information. In the Motion and the ancillary documents filed in support thereof, the Receiver reports that he has identified certain people who thought that they had invested their money in "side accounts" established by the

defendant(s) (the "Affected Investors"). The Receiver seeks authority to follow certain procedures in order to protect the personal identification of the Affected Investors, consistent with LR 5.5 (d), when filing pleadings and notices of intent containing their personal identification information.


The Court, having considered the motion, having been informed that defendants have no objection to the Motion, and having been informed that no objections to the Motion were filed, it is hereby

ORDERED that the Receiver, when filing pleadings and/or notices of intent to take certain actions that may affect the Affected Investors or when the Receiver is filing documents with this Court that contain certain identification information regarding the Affected Investors, is authorized to: (1) submit certificates of service redacting the address or other contact information for the Affected Investors; (2) redact personal identification information regarding the Affected Investors in all documents that the Receiver files in this case; and (3) file a reference list under seal of the Affected Investor personal identification information redacted.
