**ORDER GRANTING FINAL APPLICATIONS FOR PROFESSIONAL FEES  
AND EXPENSES**

This Court, having reviewed the Fee Applications (the "Fee Applications") for the period from March 1, 2010, through closing date (the "Final Period") of (i) Michael A. Grassmueck (the "Receiver"), the duly appointed receiver for Global Online Direct, Inc. and its subsidiaries and affiliates and any entities controlled by them, (ii) Receiver's general counsel, Allen Matkins Leck Gamble Mallory & Natsis, LLP ("Receiver Counsel"), (iii) Receiver's local counsel, Arnall Golden Gregory LLP ("Local Counsel"), (iv) Receiver's forensic accountant, Financial Forensics ("Forensic Accountant"), and (v) Receiver's general accountant, Moss Adams LLP ("General Accountant"), and good cause appearing therefore, orders as follows:

1. Each of the Fee Applications filed by Receiver, Receiver Counsel, Local Counsel, Forensic Accountant, and General Accountant are approved as set forth herein.
2. The Receiver's request for fees of \$29,731.50 and costs of \$19.33 for the Final Period is granted in full. The Receiver is authorized to pay himself these amounts from receivership estate (the "Receivership Estate") funds.

3. Receiver Counsel's request for fees of \$14,789.88 and costs of \$302.88 for the Final Period is granted in full. The Receiver is authorized to pay Receiver Counsel these amounts from Receivership Estate funds.

4. Local Counsel's request for fees of \$100.00 for the Final Period is granted in full. The Receiver is authorized to pay Local Counsel this amount from Receivership Estate funds.

5. Forensic Accountant's request for fees of \$253 for the Final Period is granted in full. The Receiver is authorized to pay Forensic Accountant this amount from Receivership Estate funds.

6. General Accountant's request for fees of \$22,751 for the Final Period is granted in full, and awarded and deemed as final. The Receiver is authorized to pay General Accountant this amount from Receivership Estate funds.

7. Prior interim awards for fees and costs to the Receiver, Receiver Counsel, Local Counsel, and Forensic Accountant in this case are hereby awarded and deemed as final.
