4 1. The Motion is granted in its entirety.

5 2. The claims of investors ("Investor Claims") in this case listed on Exhibit "A"

7 amounts set forth in Exhibit "A", and the remainder of the Investor Claims are disallowed in their

17 Button Claims disallowed.
