The Court, having considered the Omnibus Objection, the Declaration of Michael A. Grassmuck in support thereof, responses, if any, and the pleadings and filed herein, the Court finds that adequate notice of the hearing was given to the Remaining Claimants, and none of the Remaining Claimants appeared at the hearing. The Court finds good cause to sustain the

1 Trustee's objections to the claims asserted by the Remaining Claimants, for allowing Claim No.
2 0001383 in the amount of \$500, and for overruling all other objections raised by the Remaining
3 Claimants. Now, therefore, it is hereby


4 ORDERED that the Trustee's Omnibus Objection is GRANTED; it is further

5 ORDERED that the claim of IW, Claim No. 1383, shall have an allowed priority claim,
6 pursuant to 11 U.S.C. § 507(a)(6), in the amount of \$500; it is further

7 ORDERED that any additional claims of the Remaining Claimants exceeding the amount
8 allowed by this Order or by any prior order of the Court shall be and hereby are disallowed.
